CURRENT ROLES

Since 2007 I have been a Consultant Clinical Psychologist at Prior Consulting, an independent clinical psychology assessment and treatment service in Cambridge. MEDICO-LEGAL TRAINING

I have been preparing reports in personal injury, clinical negligence, employment and criminal cases since 1995 and have prepared over 800 reports. I completed the Bond Solon Certificate in Civil Procedure Rules for Expert Witnesses in 2011, the Expert Witness Institute Certificate in Medico-Legal Report Writing in Civil Claims in 2013 and the Cardiff University Foundation Certificate in Medico-Legal Practice in 2015.

In personal injury cases, about 50% of reports have been for claimant, 40% defendant and about 10% of these have been single joint instructions. I have given evidence in Court, at GMC hearings and in Mental Health Review Tribunals. I am a member of the Expert Witness Institute and the Cambridge Medico-Legal Forum.
